General "Info to Know"

! ALERT - For Local District Child Protective Caseworkers From the NYS Central Register Regarding Primary/Secondary

This information is communicated on behalf of the NYS Central Register on Child Abuse and Maltreatment.

Please note that the Primary county needs to notify the Secondary county prior to closing the Intake using the "*priority closure*" reason of Duplicate. Such notification will allow the Secondary county to view the Intake, which they would otherwise be unable to do, in the event the Primary county closes the Intake as a Duplicate.



A Reminder About the Foster Care and Adoption Individual Categorical Codes in MA Cases

Please note that this piece is for local districts only and that a General Information System (GIS) message had been written on this subject - GIS 08-#002 dated February 15, 2008.

On 2/15/08 GIS 08-#002 was issued advising local districts of the creation of new WMS Medicaid Individual Category Codes (ICC) for foster and adopted children. These codes, in addition to already existing category codes, should be used by local districts when opening a Medicaid case for foster children - case type 13 or 20 - or when opening

a Medicaid adoption subsidy case. The chart below includes both new and existing individual category codes. The use of these codes will help to identify children in foster care that are in receipt of Medicaid.


