## APPENDIX G-3

#### Reasonable Distance

#### Very Low Income

Very Low Income is defined by each district and is used in determining priorities for child care benefits.

Very Low Income is defined as **200%** of the State Income Standard.

#### Definition of Engaged In Work For Child Care In Lieu of Temporary Assistance

The minimum number of hours for Federal Fiscal Year 2006 are:

- 20 hours for a single parent with a child under the age of six years old
- 30 hours for a single parent whose children are six years of age and older
- in two parent families the parents must be working a combined total of 55 hours with at least one parent working 30 or more hours.

#### Family Share

Family share is the weekly amount paid towards the costs of the child care services by the child's parent or caretaker. The family share of child care is calculated by applying the family share percentage against the amount of the family's annual gross income that is in excess of the State Income Standard divided by 52.

**Case Closings** (select one or two)

**If it appears the expenditures will exceed allocations highest priority will be given to families with very low income and families with children who have special needs, new cases will not be opened and eligible families will be placed on the waiting list. Our district, if necessary, will first close cases in Category 3.**

2. The district has not established priorities beyond the federally-mandated priorities. If all NYSCCBG funds are committed, case closings for families which are not eligible under a child care guarantee and are not a federally-mandated priority must be based on the length of time in receipt of services. The length of time used to close cases may be based either on the shortest or longest time receiving child care services but must be consistent for all families. The district has chosen to close cases based on:

- shortest time receiving child care services
- longest time receiving child care services

**Case Openings**

The district must describe below how priority is given to federally mandated priorities and how the district will select cases to be opened in the event that there are insufficient funds available.

**Cases will be opened first if they are very low income or have children with special needs, then we will look at the waiting list, with those families whose cases were closed due to insufficient funds opened first. Category 2 families with the lowest to highest income will be opened first. Once all Category 2 families have been opened, we will open Category 3 families in reverse order of case closings. After all the families whose cases were closed due to insufficient funds have been addressed, the remaining families on the waiting list will be opened in the same order as described above.**

## **Fraud and Abuse Control Activities**

The district must identify below the criteria it will use to determine which child care subsidy applications suggest a higher than acceptable risk for fraudulent or erroneous child care subsidy payment and procedures for referring such applications to the district's front end detection system.

**Agency follows fraud plan. We look at income less than expenses, inconsistencies in information compared to previous applications, residence where care is provided, no absent parent information, previous fraud, recently separated, and we conduct an audit on 20% or not more than five per month of legally exempt providers.**

The district must describe below its sampling methodology used to determine which cases it will seek verification of an applicant or recipient's continued need for child care including, as applicable, verification of participation in employment, education or other required activities.

**We have a caseload of 400 families, and at 6-month intervals, after the case is opened we send out a form (six month mailer) for the client to complete to determine if there are any changes. We look at 100% of our open cases.**

The district must describe below its sampling methodology used to determine which child care providers of subsidized child care services they will review for the purpose of comparing the child care providers attendance forms for children receiving subsidized child care services and any child and adult care food program inspection forms to verify that child care was actually provided on the days listed on the attendance forms.

**We request a schedule of work hours at application and recert. When paying a provider without a contract (legally exempt providers, registered providers and some centers), we compare the paycheck hours and the work schedule to the attendance to determine if the billed hours are correct. If there is a contract with the local district (only daycare center), we do not require pay stubs with every bill, we check at six month recert and reapplication. On a yearly basis the caseload is an average of 400 families. To verify if there are any changes to the case, agency sends out a six-month eligibility questionnaire. Currently the number of providers that participate in the food program is so low (13), we do 100% verification of all attendance forms. If these increase above 200 providers enrolled in the food program, we will then randomly sample 20% of the cases.**

**APPENDIX G-8**  
**ADDITIONAL LOCAL STANDARDS FOR CHILD CARE PROVIDERS**

The district may propose local standards in addition to the State standards for providers who will receive child care subsidies.

1. Described below are the additional local standards that will be required of providers as well as which providers must comply with each additional standard.

**Providers of legally exempt child care and all household members 18 years of age and older will be asked to sign a release which will allow the Ontario County of Department of Social Services to conduct a local child welfare database check.**

**If a legally exempt provider or household member refuses to sign the release, which would allow Ontario County Department of Social Services to review all existing child welfare records, the enrollment package will be considered incomplete and the enrollment process cannot move forward and will be withdrawn by the enrollment agency. If the provider does not comply, the parent is sent notice by the enrollment agency that their provider cannot be considered a legally exempt provider. The Department will inform the parent/caretaker of the refusal so that they can consider the refusal when they make a decision to select the provider. In this situation, parents will be reminded of their right to choose another provider and will be given information about how to locate other providers.**

**When a local database check reveals that a legally exempt provider and/or household member(s) age 18 years of age and older are an indicated subject of a child abuse or maltreatment report the proposed provider will be required to submit to Ontario County Department of Social Services a written statement providing information concerning the indicated incident(s). This statement must be signed by the parent/caretaker acknowledging receipt of this information and the parent/caretaker's wish to use this child care provider.**

**If the information regarding the indicated child protective report does not correlate with the information obtained from the local database, check our Department will notify the provider that they have five calendar days to clarify the discrepancies in the information submitted to the Department and parent/caretaker. Within that five calendar day period the provide must submit information to our Department and the parent/caretaker that either correlates with the information obtained by the Department's local database check or the provider submits information obtained by our Department which documents that the information obtained from the local database check is inaccurate. If the provider fails to clarify the discrepancies the district will notify the Enrollment Agency that the additional standard has not been met.**

**If the information regarding the indicated child protective report correlates with the information obtained from the local database check and there are no other health and safety concerns and the parent/caretaker still chooses to use the provider, the Enrollment**

**Agency will be notified that the additional standard has been met. In some cases, our district may need to inform the parent that the parent's decision to place their child in the care of this provider would place their child at risk. As mandated reporters, staff is obligated to make a report of suspected child abuse or maltreatment if placing the child in the care of a provider would place the child in imminent danger of impairment and the parent/caretaker nevertheless places the child in the provider's care. Parents will be informed of their right to choose an alternative provider and be given information on how to locate other providers.**

**If the local database check reveals that the provider has an active or open preventive or protective case the Department will not recommend enrollment unless the Commissioner of Social Services approves. The Commissioner will review if the provision of child care by the provider/preventive service recipient would cause health and safety concern for the children. All assessments would need to be completed within a 10 day period of the provider's enrollment request.**

2. Described below are the methods and resources that will be utilized to determine that these additional local standards are being met.

**When a provider and all household members 18 years of age and older have signed the release which allows our Department to conduct a local child welfare database check, out designated Department staff will check the local child welfare database for indicated reports of child abuse or maltreatment and open preventive cases. The results of the local child welfare database check will be given to the Childcare designated person for appropriate action as described in the response to item one above.**

**If the local child welfare database check reveals an indicated child protective report the childcare staff will follow the procedures outlined in item number one above. If the local child welfare database check reveals that the provider has an active or open preventive case the provider will not be enrolled until the preventive caseworker writes a statement approving the enrollment. The information will then be given to the Commissioner for recommendation. When the preventive caseworker has completed the assessment of the provider/preventive services recipient's ability to provide care for other children without increasing the likelihood that the provider/preventive services recipient's own children will be placed into foster care, the preventive caseworker will notify the enrollment agency as to whether or not the additional standard has been met.**

3. Described below are the procedures the district will use to notify the Legally Exempt Caregiver Enrollment Agency as to whether or not the legally exempt provider is in compliance with the additional local standards. (Districts only need to describe this procedure if the additional local standard is applied to legally exempt child care providers.)

**The district will notify the enrollment agency in writing or email as to whether or not the additional standard has been met. The district will maintain a file, which will document the information used to determine if the standard has been met or not.**

4. Described below is the justification for each additional standard.

**To insure information that could affect the safety of the children in legally exempt child care setting is shared. The Ontario County Department of Social Services wants to make sure that providers have told parents about known child protective histories. In rare situations, providers are deemed unsafe to be around any children by the Family and Children Services Units due to a serious child abuse history and the Department wants to make sure parents have a chance to make educated decisions about using providers.**

## **Waivers**

Districts have the authority to request a waiver of any regulatory provision that is non-statutory. Describe and justify why your district is requesting a waiver.

Ontario County Department of Social Services is requesting a waiver to change the protocol for childcare subsidy cases with support orders of non-custodial parent's share of child care expenses. Effective 1/1/09 Ontario County will no longer require custodial parents who receive childcare subsidy funds to file a violation petition against the non-custodial parent when the non-custodial parent who is not paying his/her share of the childcare expenses as ordered. The problem with the violation is that the custodial parent has to take time off from work and many times the issue is not resolved, causing more time off to attend court. Per reviewing the cases for cost/benefit of the violation it was concluded that the costs with regard to client/staff time far outweigh any possible value.

## **Breaks in Activities**

Districts may pay for child care services for low income families during breaks in activities for a period not to exceed two weeks or for a period not to exceed one month where child care arrangements would otherwise be lost and the subsequent activity is expected to begin within that period (check one).
