SUBJECT: At Risk Low Income and Transitional Child Care Programs

The Governor has proposed significant restructuring to child care subsidy programs. Until these changes are enacted into law, existing statutes and regulations regarding the administration of child care subsidy programs remain in effect.

New York State has received its first allocation of federal funds under the new Child Care Development Fund. To ensure that families currently being served under ARLICC do not lose child care subsidy support during the process of enacting the Governor's proposals, the Department is issuing an allocation of federal funds for districts to continue the At Risk Low Income Child Care (ARLICC) program for the period October 1, 1996 through March 31, 1997. Reimbursement is also available, under existing terms and conditions, for districts to maintain, at their present caseload level, child care subsidy support to families under the Transitional Child Care program.

The Attachment lists each district's allocation of federal funds for ARLICC for the period October 1, 1996 through March 31, 1997. The State share for ARLICC is deducted from the district's allocation for the State Low Income Day Care program. For details on the At Risk program, refer to 95 LCM-93 dated August 15, 1995.
