Previously, these rates were transmitted annually to you via Division for Youth Administrative Bulletins. These rates have been calculated using the approved methodology and have been certified in accordance with Section 529 of the Executive Law. Local districts are required to pay these rates which form the basis of the Office of Children and Family Services' quarterly cost of care bill. These rates will remain in effect until new rates are certified.
