Note: There were a number of reasons that could be selected for stays over 45 days. For ease of presentation, these were summarized into categories. The reasons are:

**COURT ISSUES:** New charges/additional crimes; Process longer due to severity of charges; Additional fact-finding ordered; Changing disposition to another court; Dropped down from criminal court; Waiting for another county to prosecute; Court calendar issues; Judge's discretion to continue detention; Other court issue.

**PROCESSING DELAYS:** Awaiting probation investigation/report; Awaiting special evaluation(s); Awaiting court papers before moving child; Law Guardian/Prosecutor delay; Waiting for other relative resource; Other processing delay.

**PLACEMENT AVAILABILITY:** No placement available in child's county/geographic area; No placement available for child's needs; No agency will accept child; Placement found, awaiting opening; Judge will not approve placement that was found; Exploration of placement; Other placement issue.

**TREATMENT RELATED:** Need to address child's medical problems for health/safety; Need to address child's mental health problems for health/safety; Held to finish school year; Family needs intervention before child comes home; Other treatment related.
