This Memorandum is to inform local social services districts that the Department is making additional Child Care and Development Block Grant (CCDBG) funds available to social services districts for that child care subsidy program for the current federal fiscal year (FFY 95-96). This increase is based on the State's determination to use a larger proportion of the State's CCDBG funds for subsidies for the current year. The additional funding may not be available in subsequent years.

Attachment A lists each district's total allocation of CCDBG subsidy funds for the period October 1, 1995 through September 30, 1996. The allocations listed in Attachment A include the district's original CCDBG allocation plus the district's new additional funding. Attachment A replaces the allocations listed in 95 LCM-136 (Attachment A).

There are no additional requirements to receive these funds. Those social service districts that already have submitted the letter of intent to

Any district that has not submitted the required letter of intent must submit such a letter in accordance with the instructions in 95-LCM-136 prior to using these funds. Districts must expend these funds by September 30, 1996.
