- New authorization: for families, the earliest case authorization date for any member of the case is recognized as the family's start date.
- Served: children / families authorized with preventive services for one day or more in a particular month, a child / family may be served in multiple months
- Services authorization ended: if a family has multiple members authorized for services, end date reflects the date on which services were no longer authorized for any family member.
