Rensselaer County would like to make two changes to the 2012-2016 Day Care Plan, which was approved effective June 12, 2012. In the approved plan the weekly family share is 25%. On November 1, 2012, Rensselaer County would like to change the weekly family share to 35%. The second change is to the definition of low income standard.
