Dear Chief Executive Officer,

Thank you for submitting Nassau County's Supervision and Treatment Services for Juveniles Program (STSJP) plan for Program Year (PY) 2022-2023. Your entire STSJP plan, including any amounts listed for PY 2022-2023 STSJP-RTA, has been **approved**.

The County is eligible to receive 62% State reimbursement for STSJP expenditures up to the capped STSJP allocation amount. Your municipality will continue to receive 49% State reimbursement for eligible detention services expenditures up to the capped allocation amount. If your municipality shifts a portion of its detention allocation into its STSJP plan, your municipality will receive 62% State reimbursement, up to the capped allocation, if such shifted funds are spent on STSJP eligible expenditures. A municipality may make a detention allocation shift at the time of the STSJP plan submission or up until June 30, 2023, unless otherwise approved by the Office of Children and Family Services.

If the County plans to shift its detention allocation for STSJP eligible expenses, please submit a request on official letterhead to Lynn Tubbs and email it to stsjp@ocfs.ny.gov outlining

1. the amount that will be shifted and
2. the type of programming or services the re-purposed detention funds will be used for under STSJP

Once the shift is approved, an amended STSJP plan will need to be submitted.

As a reminder, to access RTA reimbursement that a municipality may be eligible for, the expenditures must be specifically included in a locality's comprehensive RTA plan.

All STSJP claims, inclusive of STSJP-RTA, must be submitted electronically via the Juvenile Detention Automated System (JDAS) for the service period of October 1, 2022 to September 30, 2023. In 2021, 412 youth were arrested and either brought to the Juvenile Detention Center or released on an FCAT. Of these, 63 were brought to the Juvenile Detention Center, 36 were removed from the Youth Part of District Court, 8 were removed from Family Court and 305 were issued an FCAT.

The below zip codes represent the largest percentages within Nassau County. Notably Zip code 11550 was grossly overrepresented. Contributing factors include poverty, lack of mentorship, drug use, poor school attendance, and lack of engagement in structured community based activities.

In comparison to detention admissions to the general population, several demographics were over represented. These demographics include Males, Black/African American, and Hispanic. Programs within Nassau County's Annual plan will attempt to focus on programming to reduce detention and placement as well as engage youth groups that are overrepresented in detention and placement admissions.

Nassau/Suffolk Youth Justice team meets quarterly with all stakeholders to discuss regional goals and plans to achieve better outcomes. These meetings are attended by community members, providers, and criminal justice personnel with the goal of public safety as well as reducing criminogenic risk factors in youth which promulgate behaviors that lead to placement and detention. It is through these collaborative efforts that STSJP programs are inspired and implemented.

2. How is your municipality gathering participant youth and family feedback as part of your STSJP plan development?

Verbal feedback by Youth and their family to provide feedback regarding STSJP plan development. In addition, the YASI case plan allows Probation to discuss the goals of Probation supervision as it identifies the youth's areas of risk and the plan of action needed to make improvements. As many of these programs are being piloted by the Probation Department, youth have been able to help influence the implimentation of STSJP programs. Families

and youth also provide written feedback which is later used in multiple areas including STSJP program development, program admission determination, and needs assessments.

Most of the programs are still being molded to meet the dynamic needs of the youth and communities we serve. As such, staff utilize the feedback received from previous participants to help enroll new youth and their families.

When a youth is arrested and brought to the precinct, police must decide whether to release to the parent on an FCAT (Family Court Appearance Ticket) or to lodge the youth at the Juvenile Detention Center (JDC). Reasons for lodging a youth normally include inability to locate a parent, parent refusal to pick up child at precinct, arrest charges are domestic in nature, youth is a runaway risk, or youth is a risk for future criminal activity.

Prior to the initiation of the FCAT OT STP grant in 2012, these youth were immediately filed as Juvenile Delinquency cases and seen by a Judge in Family Court. In 2012, the FCAT OT grant was initiated which places specially trained PO’s on call 5pm to 12 am weekdays and 9am to 12am on weekends to respond to the JDC upon notification that a youth has been arrested. The youth is held in a separate location at the JDC (apart from the youth currently detained in the JDC) until assessed by a PO who will determine if the youth can be returned home or an alternate location can be found i.e. a runaway/homeless youth shelter, relatives home etc. The youth is then released on an FCAT by the Probation Department with the plan to divert the case from formal court action if appropriate.

Originally this program was utilized by Officers as a progressive sanction to avoid Violations of Probation which result in placement or detention. It has since expanded to be utilized by the Courts in pre-dispositional matters for alleged JD's, JO's, AO's and PINS. The use of this electronic monitoring program by the Court reduces the risk/reliance on pre-dispositional detention at the juvenile detention center and placement within the custody of the Department of Social Services.</p> <p>The Early Intervention category will be utilized to account for alleged PINS youth who have been Court ordered to wear a GPS device. The Alternative to Detention/Pre-Dispositional Placement category will be utilized for alleged JD, JO, and AO's who have been Court ordered to wear a GPS device. The Alternative to Placement category will be utilized for adjudicated PINS and JD's who are under the supervision of Probation and have a GPS fitted as an alternative to filing a violation of Probation.</p>

 Average length of stay for 2021 detentions in Nassau County was approximately 41 days. Although the average length of stay for electronic monitoring is slightly longer, it is an opportunity to engage youth in the community as opposed to detention.

Probation will be working with community based programs to increase engagement with youth in programs that focus on mentorship and employment skills. Many youth engaged by Probation have poor school attendance and little employable skills. The zip code which had the highest detention rate for 2021 also had a high school graduation rate below the state average. The high school graduation rate for NYS in 2021 was 86%. The high school graduation rate fo Nassau County was 94%. The graduation rate for zip code 11550 was 72%. While efforts are being made from school districts to improve graduation rates youth that have criminal justice involvement have additional barriers towards earning a high school diploma. This program is aimed at offering youth additional oppourtunities to succeed by offering mentorship, structed leisure activities as well as training in employable areas including science, tehcnology, engineering and math.
