Dear Chief Executive Officer,

Thank you for submitting Nassau County's Supervision and Treatment Services for Juveniles Program (STSJP) plan for Program Year (PY) 2023-2024. Your entire STSJP plan, including any amounts listed for PY 2023-2024 STSJP-RTA, has been **approved**.

The County is eligible to receive 62% State reimbursement for STSJP expenditures up to the capped STSJP allocation amount. Your municipality will continue to receive 49% State reimbursement for eligible detention services expenditures up to the capped allocation amount. If your municipality shifts a portion of its detention allocation into its STSJP plan, your municipality will receive 62% State reimbursement, up to the capped allocation, if such shifted funds are spent on STSJP eligible expenditures. A municipality may make a detention allocation shift at the time of the STSJP plan submission or up until June 30, 2024, unless otherwise approved by the Office of Children and Family Services.

If the County plans to shift its detention allocation for STSJP eligible expenses, please submit a request on official letterhead to Lynn Tubbs and email it to stsjp@ocfs.ny.gov outlining

1. the amount that will be shifted and
2. the type of programming or services the re-purposed detention funds will be used for under STSJP

Once the shift is approved, an amended STSJP plan will need to be submitted.

As a reminder, to access RTA reimbursement that a municipality may be eligible for, the expenditures must be specifically included in a locality's comprehensive RTA plan.

All STSJP claims, inclusive of STSJP-RTA, must be submitted electronically via the Juvenile Detention Automated System (JDAS) for the service period of October 1, 2023, to September 30, 2024. Of these 609 were arrested and brought to either Juvenile Detention or released on a Family Court Appearance Ticket. 92 were removed from the Youth Part of Nassau County District Court.</p> <p>The below zip codes represent the largest percentages within Nassau County. Notably Zip code 11550 was grossly overrepresented. In comparison to detention admissions to the general population, several demographics were over represented. These demographics include Males, Black/African American, and Hispanic. Programs within Nassau County's Annual plan will attempt to focus on programming to reduce detention and placement as well as engage youth groups that are overrepresented in detention and placement admissions.

Nassau/Suffolk Youth Justice team meets quarterly with all stakeholders to discuss regional goals and plans to achieve better outcomes. These meetings are attended by community members, providers, and criminal justice personnel with the goal of public safety as well as reducing criminogenic risk factors in youth which promulgate behaviors that lead to placement and detention. It is through these collaborative efforts that STSJP programs are inspired and implemented.

Verbal feedback by Youth and their family to provide feedback regarding STSJP plan development. In addition, the YASI case plan allows Probation to discuss the goals of Probation supervision as it identifies the youth's areas of risk and the plan of action needed to make improvements. As many of these programs are being piloted by the Probation Department, youth have been able to help influence the implementation of STSJP programs. Families and youth also provide written feedback which is later used in multiple areas including STSJP program development, program admission determination, and needs assessments.

When an alleged juvenile delinquent is arrested and brought to the precinct, police must decide whether to release to the parent on an FCAT (Family Court Appearance Ticket) or to lodge the youth at the Juvenile Detention Center (JDC). Reasons for lodging a youth normally include inability to locate a parent, parent refusal to pick up child at precinct, arrest charges are domestic in nature, youth is a runaway risk, or youth is a risk for future criminal activity.

Prior to the initiation of the FCAT OT STP grant in 2012, these youth were immediately filed as Juvenile Delinquency cases and seen by a Judge in Family Court. In 2012, the FCAT OT grant was initiated which places specially trained Probation Officers (PO) on call 5pm to 12 am weekdays and 9am to 12am on weekends to respond to the JDC upon notification that an alleged juvenile delinquent has been arrested. The youth is held in a separate location at the JDC (apart from the youth currently detained in the JDC) until assessed by a PO who will determine if the youth can be returned home or an alternate location can be found i.e. a runaway/homeless youth shelter, relatives home etc. The youth is then released on an FCAT by the Probation Department with the plan to divert the case from formal court action if appropriate under the adjustment process.

3. Based on the program’s record of youth served, do you anticipate this program serving more or less than its projected capacity on 9/30/2023? Please explain:

The 2022 plan raised the projected capacity of the program by approximately 66%. As a result new officers were trained in order to accommodate the projected need. The 1st period's report shows that 42% of the year's program goal has been reached. This is 8% lower than the projected analysis. It should be noted that while the program is underperforming slightly, the capacity projection was increased significantly and the factors which determine if an alleged juvenile delinquent is brought to the Juvenile Detention Center are beyond the control of the Probation Department.

The average length of stay is as expected as typical service lasts from 60 to 90 days. The ALOS is from the 1st period is within the expected range. While ALOS is greater than the ALOS for JD detentions in 2022, it is the program's goal not just to release a youth but work with them in the community following the release in order to secure interventions are in place to reduce recidivism.

The use of electronic monitoring within Nassau County for youth entering the Court system has been used across various populations including JD, JO, AO, and PINS. Originally this program was utilized by Officers as a progressive sanction to avoid Violations of Probation which result in placement or detention. It has since expanded to be utilized by the Courts in pre-dispositional matters for alleged JD's, JO's, AO's and PINS. The use of this electronic monitoring program by the Court reduces the risk/reliance on pre-dispositional detention at the juvenile detention center and placement within the custody of the Department of Social Services.

The Early Intervention category will be utilized to account for alleged PINS youth who have been Court ordered to wear a GPS device. The Alternative to Detention/Pre-Dispositional Placement category will be utilized for alleged JD, JO, and AO's who have been Court ordered to wear a GPS device. The Alternative to Placement category will be utilized for adjudicated PINS and JD's who are under the supervision of Probation and have a GPS fitted as an alternative to filing a violation of Probation.

 In the first period, the electronic monitoring program has served approximately 76% of the projected capacity. Electronic monitoring continues to be used across populations as an effective intervention strategy and similar trends for the second period are anticipated. Should they continue the same trends as the first period, the program will over perform its projected capacity.

5. How does the average length of service compare to what you would expect for that service type? For ATD/ATPDP and ATP service types, compare with the average length of stay for youth who were in detention and residential placements during the same time period.
 The ALOS for each service type is to be expected, For the EI and ATD/ATPDP categories the use of electronic monitoring is indicated via Court order and removed at the order of the Court. Adjournment dates are typically three to four weeks. Based on the ALOS for these categories it would give the Court two opportunities to assess the effectiveness of electronic monitoring versus detention/remand. For the ATP category, electronic monitoring is being used as an alternative for filing a violation of Probation which could lead to placement. Use of the devices for that period of time gives the officers a better opportunity to assess the effectiveness of the electronic monitoring versus filing a violation of Probation.
