Dear Chief Executive Officer,

Thank you for submitting Oneida County's Supervision and Treatment Services for Juveniles Program (STSJP) plan for Program Year (PY) 2023-2024. Your entire STSJP plan, including any amounts listed for PY 2023-2024 STSJP-RTA, has been **approved**.

The County is eligible to receive 62% State reimbursement for STSJP expenditures up to the capped STSJP allocation amount. Your municipality will continue to receive 49% State reimbursement for eligible detention services expenditures up to the capped allocation amount. If your municipality shifts a portion of its detention allocation into its STSJP plan, your municipality will receive 62% State reimbursement, up to the capped allocation, if such shifted funds are spent on STSJP eligible expenditures. A municipality may make a detention allocation shift at the time of the STSJP plan submission or up until June 30, 2024, unless otherwise approved by the Office of Children and Family Services.

If the County plans to shift its detention allocation for STSJP eligible expenses, please submit a request on official letterhead to Lynn Tubbs and email it to stsjp@ocfs.ny.gov outlining:

1. the amount that will be shifted and
2. the type of programming or services the re-purposed detention funds will be used for under STSJP.

Once the shift is approved, an amended STSJP plan will need to be submitted.

As a reminder, to access RTA reimbursement that a municipality may be eligible for, the expenditures must be specifically included in a locality's comprehensive RTA plan.

All STSJP claims, inclusive of STSJP-RTA, must be submitted electronically via the Juvenile Detention Automated System (JDAS) for the service period of October 1, 2023, to September 30, 2024. Oneida County is located in Central New York. The two major cities that make up the urban area of our county are Utica (13501 & 13502) and Rome (13440), which are where the majority of our youth involved in the juvenile justice system reside. The county is also made up of 56 smaller rural towns and villages. The county continues to struggle with unemployment, low wage jobs, and poverty. There are also ongoing concerns with substance abuse, violence, and lack of treatment providers for both substance abuse and mental health. Through partnerships with local school districts, probation, and community agencies we attempt to meet the needs of our most vulnerable population of youth at the onset of identified issues or concern. Central New York Health Homes RIYS program works hand in hand with the department in providing preventive and aftercare services to ensure goals are being met and youth and families are transitioned and supported by evidenced based community services. This service focuses on the family as a unit and not only the youth identified, utilizing the philosophy of wrapping services around the family as a unit and ensuring all members are getting what supports necessary to maintain the identified youth in the home. The Department has also initiated a GPS monitoring program to maintain youth in the community and out of placement the goal is to work with the youth in a community setting so the youth can be engaged in a positive way and also maintain monitoring to help redirect incorrigible delinquent behaviors.

b) If you identified any disparities when comparing youth representation in the general population and their representation in detention and placement, explain how this plan will address those disparities. If you did not identify any disparities, please note such.

Proportionally from the data listed above 73% of Oneida Counties general population under 18 is white and the percentage of white youth detention admissions was 30%. 10% of Oneida Counties general population under 18 is black/African American and the detention admissions was 62%. The Hispanic general population under 18 makes up 11% of Oneida County and their detention admissions was 3%. Asian/Pacific Islander and Native American/Alaskan general population under 18 makes up 7 % of the population and the detentions admissions were 5%. This data suggests that the 2022 detention admissions and placemnt data show disproportionately Black youth. Through community outreach and partnerships with probation, courts and schools in the urban areas we will identify youth at the onset of truancy, incorrigible behaviors and involvement with law enforcement. Using strength based services and positive engagement focused on families and youth with the wraparound philosophy, youth will be able to be safely maintained in the home and community. Oneida County continues to use the Blind Review process to review placement cases prior to placement in an effort to eliminate racial disparity. We continue to provide trainings that educate our staff on the issues of racial disparity.

B. Local Collaboration

Oneida County has several partnerships and contracts with local agencies. We currently hold ongoing monthly meetings with our probation department. We have also staffed a juvenile probation officer located directly with our Child Protective units. This collaboration allows for immediate response at the first signs or reports of incorrigible behaviors by both entities. A partnership with Community Schools has opened communication and partnerships with local school districts. This fosters a more immediate and unified response to our youth in need.

The Services Division and probation remain active participants in the Youth Council. Our intention is to engage at risk youth in a positive way before the court system becomes involved, or before youth are so disengaged it is difficult to engage them in a meaningful way. Our contract with Central New York Health Homes, known as RIYS (Restorative Integrated Youth Services) provides diversion services for the STSJP identified population. This program attempts to redirect incorrigible delinquent behaviors through the development of individualized programs that utilize a variety of community resources. This program will follow up with ongoing planning and support services to maintain the youth in the home and community safely while promoting family stability and pro-social behaviors for youth and family. The Department has initiated a contract with the Probation Department for monitoring of at risk youth through GPS bracelet in an effort to keep these youth in the community and out of placement.

Through team meetings which includes the youth and family provides the family a voice and a choice. These meetings provides us with needed feedback to improve outcomes for the youth and family. This feedback also assists in the development of the STSJP plan annually.

 The RIYS program will serve adjudicated non-RTA and RTA youth as an alternative to placement and non-RTA youth at reentry to assist the successful reintegration into the community. The average length of services provided will be from 6-12 months with an end goal to transition the youth and family to community based services which will continue to provide support. Each case will consist of an individualized service plan that will meet the unique needs of each identified youth and their family. The services plan will coordinate a menu of wrap around services that will help family/caretakers manage the youth's behaviors to ensure the home is safe and nurturing with adequate supervision and models of effective parenting. The youth will be provided with services that encourage positive outlets in the community and at home to reduce negative behaviors and increase youths success in school and encourage independent living skills.

The SPIN program follows the principles of the wraparound philosophy. Services are strength based and individualized to the specific needs of the youth and family. SPIN is a fee for service program that allows services to be tailored to the family so youth can remain safe in the home and in the community. This service is unique in that it can be used in conjunction with other services to create an intensive in home service that support positive outcomes. Intensive ICAN and Step Down programs offer strength based and family focused services using the wraparound philosophy with the primary goal of keeping families together. Through flexible programming, and cross system collaboration youth and families will be successfully engaged and able to remain in the community. This program will serve RTA youth as an alternative to detention, adjudicated RTA youth as an alternative to placement and upon reentry to assist with successful community reintegration.
