Dear Chief Executive Officer,

Thank you for submitting Onondaga County's Supervision and Treatment Services for Juveniles Program (STSJP) plan for Program Year (PY) 2022-2023. Your entire STSJP plan, including any amounts listed for PY 2022-2023 STSJP-RTA, has been **approved**.

The County is eligible to receive 62% State reimbursement for STSJP expenditures up to the capped STSJP allocation amount. Your municipality will continue to receive 49% State reimbursement for eligible detention services expenditures up to the capped allocation amount. If your municipality shifts a portion of its detention allocation into its STSJP plan, your municipality will receive 62% State reimbursement, up to the capped allocation, if such shifted funds are spent on STSJP eligible expenditures. A municipality may make a detention allocation shift at the time of the STSJP plan submission or up until June 30, 2023, unless otherwise approved by the Office of Children and Family Services.

If the County plans to shift its detention allocation for STSJP eligible expenses, please submit a request on official letterhead to Lynn Tubbs and email it to stsjp@ocfs.ny.gov outlining

1. the amount that will be shifted and
2. the type of programming or services the re-purposed detention funds will be used for under STSJP

Once the shift is approved, an amended STSJP plan will need to be submitted.

As a reminder, to access RTA reimbursement that a municipality may be eligible for, the expenditures must be specifically included in a locality's comprehensive RTA plan.

All STSJP claims, inclusive of STSJP-RTA, must be submitted electronically via the Juvenile Detention Automated System (JDAS) for the service period of October 1, 2022 to September 30, 2023. A. Municipality Level Analysis

In 2021, youth living in four contiguous zip codes within the City of Syracuse (13204, 13205, 13203, & 13208) account for 46% of supervision cases, 64% of the unduplicated detention admissions, and 58% of placements. It should come as no surprise that the communities within the aforementioned zip codes have been historically overrepresented in a variety of areas and yield the highest rates of poverty, child welfare involvement, lead paint levels, teenage pregnancy, etc. It should be noted that the over representation for youth from the identified zip codes are down considerably since the start of the STSJP supported, Community Engagement Initiative. In 2016, youth from these zip codes accounted for 60% of supervision, 68% of detention, and 83% of placement cases respectively.

Onondaga County has made a concerted effort to support youth (and their families) who have exhibited "PINS-related behaviors" with other supportive services rather than Family Court involvement. As a result there are not currently any youth adjudicated as a PINS on formal probation and two youth adjudicated as a PINS in placement. PINS related services are not funded through the use of STSJP funding in Onondaga County.

While Onondaga County has made significant progress in reducing racial and ethnic disparities, Black/African American youth still are overrepresented in our local youth justice system. Through several current initiatives (the Policy Equity Academy through DCJS and the Youth Justice Institute and the Results Based Leadership Project which has been offered through the Central Regional Youth Justice Team) we have identified four strategies that are specifically intended to reduce disparities. While all of the requested STSJP contracts have historically aided in disparity reduction, two of the newly developed strategies involve several of the current contracted providers.

B. Local Collaboration

The Onondaga County Partnership for Youth Justice vision is that all youth involved in the Juvenile Justice System are given an opportunity to safely stay in their community and receive community based supports that are culturally competent in order to successfully transition to adulthood.

The Partnership's Steering Committee (which is comprised of service providers, organizational leaders, county department heads, law enforcement, judiciaries, attorneys, court staff, individual from faith-based organizations, probation officers, school district personnel, and interested community members) meets bi-monthly and is the advisory body of the collaborative which makes recommendations and provides feedback on priority areas, system gaps, and needs.

As it relates to the STSJP Plan, the Partnership reviews data, creates an annual work plan, as well as contributions to strategic planning focusing on meeting targets and goals. The Partnership also looks at the resources available including STSJP, local funding dedicated to placement, outside grants and partnerships to fund strategies that will fund a continuum of programs and services and interventions that will provide lasting impact on youth and their pathway to successful adulthood.

2. How is your municipality gathering participant youth and family feedback as part of your STSJP plan development?

While there has been a high level of participation from a diverse group of community members in the past, youth and family input has not not been part of the STSJP development process.

Describe how the plan incorporates that feedback; if you have not yet received youth and family feedback, please describe the barriers to implementation and the municipality's solutions to develop such feedback mechanisms during PY 2022-2023.

The Community Engagement Initiative Coordinator is responsible for holding focus groups, conduct surveys, and illicit youth/family input on service/system gaps as well as to identify ways that families can better be supported. Due to the position being vacant for a significant portion of 2021, and due to barriers associated with the COVID pandemic, we did not achieve that same level of family input as we had tapped into historically. It should be noted that, while not funded through STSJP, we conducted a youth survey for input into an additional service that has been developed in 2022 and will be contracted in 2023. A total of four hundred and fifteen youth completed the survey that will drive programmatic options moving forward.

While the local Steering Committee is comprised of individuals from many areas of the county, concerted efforts have been made to ensure that community members, service providers, and other interested individuals that work and live in the zip codes that yield the majority of system involved youth are represented. This has been accomplished by not only extending invitations to individuals directly, but also through contract request for proposals which specifically identify that organizations main site of operations must fall in certain geographic zip codes as well as encourage organizations to employ individuals who live in the areas that they serve.

The Special Supervision Program was designed to reduce the reliance on the use of detention for youth with pending Juvenile Delinquency, Juvenile Offender, and Adolescent Offender cases by providing intensive supervision and case management services to children and families awaiting case disposition. Special Supervision will monitor each child at home, school, and within the community to ensure they return to court and refrain from committing future law violations.

Lengths of service in the program are very comparable to the ALOS for JO's & AO's in Detention (80 days & 76 days respectively). JD youth have significantly shorter ALOS's in detention (21 days).

315 L.I.F.T. combines life coaching/mentorship, entrepreneurship classes and opportunities, and community-based conflict resolution (peacemaking). Youth receive three hours of life coaching every week and will attend bi-weekly life skills group sessions developed by the Good Life Foundation (GLF). Bi-monthly skill-building sessions in financial literacy and entrepreneurship will be held. The program will serve RTA and non-RTA youth in an attempt to prevent placement or to provide support upon re-entry to the community.
