Dear Chief Executive Officer,

Thank you for submitting Otsego County's Supervision and Treatment Services for Juveniles Program (STSJP) plan for Program Year (PY) 2022-2023. Your entire STSJP plan, including any amounts listed for PY 2022-2023 STSJP-RTA, has been **approved**.

The County is eligible to receive 62% State reimbursement for STSJP expenditures up to the capped STSJP allocation amount. Your municipality will continue to receive 49% State reimbursement for eligible detention services expenditures up to the capped allocation amount. If your municipality shifts a portion of its detention allocation into its STSJP plan, your municipality will receive 62% State reimbursement, up to the capped allocation, if such shifted funds are spent on STSJP eligible expenditures. A municipality may make a detention allocation shift at the time of the STSJP plan submission or up until June 30, 2023, unless otherwise approved by the Office of Children and Family Services.

If the County plans to shift its detention allocation for STSJP eligible expenses, please submit a request on official letterhead to Lynn Tubbs and email it to stsjp@ocfs.ny.gov outlining

1. the amount that will be shifted and
2. the type of programming or services the re-purposed detention funds will be used for under STSJP

Once the shift is approved, an amended STSJP plan will need to be submitted.

As a reminder, to access RTA reimbursement that a municipality may be eligible for, the expenditures must be specifically included in a locality's comprehensive RTA plan.

All STSJP claims, inclusive of STSJP-RTA, must be submitted electronically via the Juvenile Detention Automated System (JDAS) for the service period of October 1, 2022 to September 30, 2023. Otsego County is a rural county of about 60,000 people. Based on its rural nature, there is not one community or zip code which can be identified as contributing to the juvenile justice system more than another community. Drug use continues to be a prevailing problem among this population. Much of this may be attributed to the lack of activities in Otsego County, especially during the COVID pandemic, and lack of transportation to the activities that do exist.

This plan was developed by meeting with a representative from DSS, Probation, the Otsego County Attorney's Office, and the Family Resource Network. Unfortunately, a representative from a local school district was not able to attend, but meeting were held between that school and the Probation Department as to which services and programs would be most beneficial to school districts.

This past year, the usage of the STSJP funds were limited, so conversations with families and youths were limited as to the feedback on the programs.

It is the goal that over the next grant year, more services will be used. During regular intervals, Probation Officers working with youths and families will discuss have discussions with the family regarding the effectiveness of the program and how to improve the programs and if their needs are being met. this information will be used to inform STSJP plan development in the next program year.

The use of drug screens aids the county and family in understanding a youth's substance use issues. This allows for appropriate recommendations for treatment, including outpatient and inpatient. The family will understand if the youth is continuing to use illegal drugs and that will allow them to make arrangements and plans with the youth to further protect them. This program will serve non-RTA youth at the diversion level to prevent further progression into the juvenile justice program, as well as an alternative to detention/alternative to pre-dispositional placement, and alternative to placement for adjudicated youth.
