Dear Chief Executive Officer,

Thank you for submitting Schuyler County's Supervision and Treatment Services for Juveniles Program (STSJP) plan for Program Year (PY) 2023-2024. Your entire STSJP plan, including any amounts listed for PY 2023-2024 STSJP-RTA, has been **approved**.

The County is eligible to receive 62% State reimbursement for STSJP expenditures up to the capped STSJP allocation amount. Your municipality will continue to receive 49% State reimbursement for eligible detention services expenditures up to the capped allocation amount. If your municipality shifts a portion of its detention allocation into its STSJP plan, your municipality will receive 62% State reimbursement, up to the capped allocation, if such shifted funds are spent on STSJP eligible expenditures. A municipality may make a detention allocation shift at the time of the STSJP plan submission or up until June 30, 2024, unless otherwise approved by the Office of Children and Family Services.

If the County plans to shift its detention allocation for STSJP eligible expenses, please submit a request on official letterhead to Lynn Tubbs and email it to stsjp@ocfs.ny.gov outlining

1. the amount that will be shifted and
2. the type of programming or services the re-purposed detention funds will be used for under STSJP

Once the shift is approved, an amended STSJP plan will need to be submitted.

As a reminder, to access RTA reimbursement that a municipality may be eligible for, the expenditures must be specifically included in a locality's comprehensive RTA plan.

All STSJP claims, inclusive of STSJP-RTA, must be submitted electronically via the Juvenile Detention Automated System (JDAS) for the service period of October 1, 2023, to September 30, 2024. There are 11 zip codes served within Schuyler County: 14805, 14812, 14815, 14818, 14841, 14865, 14869, 14876, 14878, 14887, 14891. No zip code disparities were identified as Schuyler County had 0 placements for program year 2022-2023. The District's volume of placements and detention utilization is typically low. Schuyler attributes these low metrics, in part, to the District's small populous and rural make-up, as well as strong collaboration between community service providers which allows for early identification & referrals for youth and families in need of supports.

Schuyler had zero placements in 2022 so no disparities were identified.

The Schuyler County Youth Board meets on a monthly basis to discuss Youth Court cases and to plan for programming that meets the needs of at risk youth in the community. Youth Board membership is comprised of representatives from the Youth Bureau, DSS, Public Health, Probation, Law Enforcement, Court staff, School staff, Glove House PINS-Diversion staff, Catholic Charities RHY staff, Work Force NY staff, community members, and substance abuse & mental health treatment providers.

Barriers: During STSJP program year 2022-2023 surveys were mailed to youth and their families at the time of exit from services. The mailings included post-marked envelopes for the return of the participant surveys. To date, no surveys have been received. To address this barrier in program year 2023-2024 DSS will have the youth caseworker personally provide the youth and their families with the surveys to complete during the caseworker's last visit with them so the District can obtain youth & family voice. Schuyler County Probation did receive two youth surveys following completion of supervision. However no feedback was given as to how to change or modify the program. It does appear that set goals and skills can be focused on more and strengthened from one of the surveys, and will be considered moving forward.

STSJP PY 2023-2024 funding will be used to cover the salary, fringe, and overhead costs for a DSS youth caseworker & Supervisor. The youth caseworker will:

Provide Early Intervention services (EI) to engage youth at risk of becoming, or alleged to be, a JD or PINS, or an alleged AO or JO engaged in VACPS who has not been referred for detention, to prevent further involvement in the juvenile justice system.

Provide Alternatives to Placement (ATP) services to youth adjudicated as PINS, JDs and YOs, or convicted as Jos or AOs to maintain youth safely in the community.

The number of Juveniles that we serve are generally low based on the size of our County. However, we had 1 more youth served in this period than we did in the last plan. It would seem we are right about on par with the number of youth that we expect to serve, which is right around 15 per period. We believe there is juvenile delinquent behavior being exhibited in the community, as we hear of youth committing crimes and victims needing assistance, but there appears to be a lack of juvenile tickets being written by law enforcement agencies. This could be due to several factors, such as lack of participation or support from victims, lack of evidence supporting the behavior, or lack of education on how to handle juvenile cases for police. We continue to try and educate and inform law enforcement officers of the importance of writing juvenile tickets so that these youth can receive supervision and services with direction to correct problematic behavior and to assist victims in being made whole. However, our case numbers remain lower than what we believe they should be based on these reported numbers.

At 57 days, our ATD/ATPDP average is much shorter than most detention stays or placement periods would have been. These cases are short term and sometimes progress quickly in compliance and case development ending with positive results. They can also often be closed early and referred to Court if non-compliance or risky behavior continues, which would make their time shorter in our program. An average of 57 days seems to be a good medium time for these cases and for our program to work with these youth. Especially when the average adjustment services can be up to 150 days. Our ATP program experienced an excessive amount of time over the last few periods, as we had 1 case that was under supervision for 2 full years. This is an exceptionally long amount of time for that youth to be in our program compared with a detention or placement. However, the outcome of this case was

positive, so in the long term, it was better than a detention or placement of the youth and although a longer than average stay in our services and supervision, we believe it was successful.

Yes, our goals will be met. There are currently no youth that have missed any scheduled court dates. There were no warrants issued or arrests for youth during that time period. We did have three youth sent to detention, and of them one was released back home after several weeks and two were eventually placed out of the home. One of those sent to placement was released back home after only 1 week with additional probation supervision. The other youth remains in placement still. Most youth had a positive adult connection and were engaged in a positive community activity and were able to comply with supervision requirements to achieve positive behavioral changes while working with our Office. The vast majority of youth that we served complied with the program rules and services, which resulted in good outcomes and positive case closures for this program.
