This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services has an open case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

Presenting Information

According to the information received via the OCFS 7065 form, the six-day-old child died on 11/9/21 as a result of medical complications due to prematurity and poor respiratory issues.

Executive Summary

This fatality report concerns the death of a six-day-old male subject child (SC) that occurred on 11/9/2021. At the time of writing this report, the final autopsy report was not received.

The family consisted of the mother, a three-year-old surviving sibling, and the newborn male SC. At the time of the fatality, the SC was hospitalized as he was born prematurely at 23 weeks. The father provided financial and other support to the family but resided elsewhere.

ACS' documentation revealed the SC was born prematurely and remained hospitalized as a result. The SC weighed 1.7 pounds and remained in the Intensive Care Unit at the hospital. The SC was receiving the appropriate medical care; however, he succumbed to issues surrounding his extreme prematurity.

The Specialist interviewed the parents, surviving siblings and medical providers with the family's consent. Additionally, the Specialist made referrals for the family to participate in substance abuse counseling as the mother admitted to marijuana use throughout her pregnancy. The family was also referred for community-based bereavement counseling and was engaged by the conclusion of the CPS response.

LDSS Response

Upon receipt of the information regarding the child's death, the Specialist contacted the family to arrange a home visit. The Specialist provided the family with information regarding the Family Assessment (FAR) Response. The mother agreed to be a part of the response. The Specialist conducted an assessment of the home and documented the home environment did not appear to pose any safety concerns. ACS also documented attempts to contact the father to include him in the assessment of the family.

The Specialist discussed the concerns of the report with the mother who told the Specialist of her drug use during her pregnancy. The mother indicated she was indecisive about her pregnancy but ultimately chose to continue the pregnancy. The mother stated at almost six months gestation, she went into labor and gave birth to the SC. The mother said she thought the SC would survive.

On 11/10/21, the Specialist contacted the attending physician at the hospital where the SC died and learned the child's death was the result of medical complications due to prematurity, and not the result of the mother's actions. The mother had complications with her pregnancy.

On 11/19/21 and 11/22/21, the Specialist participated in CASAC assessments. The mother was referred for substance abuse counseling.

On 12/8/21, the Specialist conducted the final assessment of the family and documented there were no safety concerns noted. The mother refused preventive services.

On 12/10/21, the FAR responses ended. ACS documented the family was engaged in counseling services through community-based provider.
