This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services has an open case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

## Presenting Information

An SCR report alleged that on 8/31/22 at 8:24 AM, an infant's leg was found at a water treatment center. Early in the morning of 9/1/22, at around 2:00 AM, the other leg to the same infant was found at the same water treatment center. The age of the infant was unknown and the date of death was approximately 8/1/22. The two unknown parents were considered the responsible adults and were named as the alleged subjects.

## Executive Summary

On 9/1/22, an SCR report was received regarding the death of the unknown, approximately 1-month-old infant. The SCR report contained allegations of DOA/Fatality and Inadequate Guardianship against the unknown mother and father. The Administration for Children’s Services (ACS) received the report and investigated the infant’s death.

The investigation revealed that on 8/31/22 at 8:24 AM, an infant's leg was discovered in the netting at a water treatment center in the Bronx. The other leg of the same infant was discovered in the netting of the same water treatment center on 9/1/22 at around 2:00 AM. The severed legs were determined to be from a female, full-term, light skinned infant. The medical examiner determined the infant was approximately 2-4 weeks of age and the legs had been in the water for up to 4 days. It was learned that the water treatment center receives 80% of the water from the Bronx as well as some water from Westchester County. The center recovers water from over 70,000 toilets, sewage drains and septic tanks. Despite investigative efforts by law enforcement and ACS, the identity of the infant and the infant's parents was unable to be determined. The law enforcement investigation remained open and DNA test results were pending at the time ACS closed the case.

ACS unsubstantiated the allegations based on a lack of information to locate or identify the infant or the parents. The medical examiner was unable to determine if the limbs were the result of a homicide, miscarriage, or still birth.

### LDSS Response

ACS investigated the infant's death by speaking to the source of the report and law enforcement. Attempts to speak to staff at the water treatment center and the medical examiner were unsuccessful. Notice of Existence letters were generated but unable to be delivered as the identity of the parents remained unknown. ACS completed Safety Assessments, the RAP and the required fatality reports to the best of their ability based on the minimal information gathered.

Law enforcement reported that they had no leads on the identity of the family. Officers reported that the medical examiner had not been able to provide any information regarding the identity and DNA testing results had not yet been received. The instrument used to sever the limbs was unable to be determined and it was unknown if the limbs were severed prior to death or after. Law enforcement further reported that the legs were caught on a water net and found by an employee at the water treatment center. Efforts to locate the rest of the infant's body were unsuccessful.

ACS made reasonable efforts to identify and locate the parents of the infant. At the time the case closed, the identity of the family remained unknown.
