This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services had an open investigation or a CPS monitored services case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

Presenting Information

On 1/19/2023, the New York City Administration for Children’s Services (ACS) became aware the 15-year-old child in foster care had become seriously injured. The child’s foster care agency became aware of the child’s injury from the foster parent (FP) and notified the child’s mother (BM). The child was playing basketball at a Police Athletic League gymnasium. Upon leaving with a group of peers, the child was approached by an unknown male and shot in the head. The child was transported by ambulance to the hospital where he was pronounced dead on 1/20/2023. The 16-year-old SS, also in foster care, was assessed as safe in the care of the foster parent. OCFS was notified of the child’s death through an OCFS 7065 Agency Reporting Form.

Executive Summary

This report concerns the death of a 15-year-old child which occurred on 1/20/2023. At the time of his death, the child resided in a foster home with his 16-year-old sibling and foster mother. Upon being notified of the child’s injury, the foster care agency, notified ACS, contacted the foster parent, biological mother, and responded to the hospital to speak with the family. Upon their arrival, they were informed the child’s prognosis was poor and death was imminent.

The foster care agency ascertained the details of the fatal incident. The child and a group of peers were leaving a basketball gymnasium when they were approached by an unknown masked male. The unknown male then shot the child in the head and another peer in the leg. The peer was treated and released from the hospital with minor injuries. The child was placed on life support and the decision was made by the mother to donate his organs and end life support. The 16-year-old sibling was interviewed and assessed as safe in the care of the foster parent. Services in relation to the death of the child were offered and existing services were utilized to support the mother and sibling.

In March 2023, an arrest was made of a 20-year-old male suspect in the shooting. There were no further updates available regarding the criminal investigation at the time this report was written.

LDSS Response

Upon being notified of the child's injury the foster care agency notified ACS, contacted the foster parent, biological mother, and responded to the hospital to speak with the family. Upon their arrival, they were informed the child's prognosis was poor and death was imminent.

The foster care agency interviewed hospital staff and law enforcement to learn the details of the fatal incident. The SC and a group of peers were leaving a basketball gymnasium when they were approached by an unknown masked male. The unknown male then shot the SC in the head and another peer in the leg. The peer was treated and released from the hospital with minor injuries. The SC was placed on life support and the decision was made by the mother to donate his organs and end life support.

The FP was interviewed and identified the SC was playing basketball with peers at the time of the shooting. The FP had no other knowledge of the incident and expressed the SC had been doing well in her care aside from difficulties attending school. The SS was interviewed and additional services were put in place to address his needs following the death of the SC. The SS was assessed as safe in the care of the FP following the fatal incident.

The BM was interviewed and did not wish to discuss the incident further with the foster care agency or ACS personnel. Services, including financial assistance for the funeral expenses, were offered, and accepted by the BM. Existing service providers were updated on the circumstances of the SC's death and altered to support the BM's needs.

The SS was interviewed and assessed as safe in the care of the foster parent. Services in relation to the death of the SC were offered and existing services were utilized to support the SS.

CPS - Investigative History More Than Three Years Prior to the Fatality

The BM had 9 substantiated investigations dating back to 2013 for educational neglect of the SC and SS, drug misuse, and not providing adequate supervision of the SC and the SS. A prevention case was opened following the initial investigation in March 2013 which transitioned to a foster care case upon the children being removed from the BM's custody in August 2018. The BM had an additional substantiated investigation in March 2004 in which she tested positive for illicit substances and was failing to provide adequate supervision of the then 9, 7, and 3-year-old children. A neglect petition was filed and the children were placed in foster care. The BM's rights were terminated and the children were freed for adoption in 2008.
