This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services had an open investigation or a CPS monitored services case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

Presenting Information

An SCR report received on 03/02/23 alleged that on the same day, while in the care of the father, the 1-month-old child was found unresponsive. The father called 911 at approximately 9:17 PM as the child was not breathing. First responders arrived at the home around 9:23 PM. The child was transported to the hospital and pronounced deceased at 10:06 PM. The child was otherwise healthy, and the father did not have an explanation for the death. A subsequent report that was received on the same day alleged the parents placed the child to sleep in a crib around 6:00 PM. The father checked on the child around 9:00 PM, and the child was unresponsive. The child was cool to the touch and was whitish-blue in color.

Executive Summary

This fatality report concerns the death of the 1-month-old subject child that occurred on 03/02/23. Reports were made to the SCR on the same day alleging the child was placed to sleep in his crib and the father later found the child unresponsive. The child died and the parents were unable to provide a plausible explanation for the death. At the time of the death, the child resided with his parents and siblings, aged 2, 5 and 6 years. The siblings were assessed to be safe with the parents.

The Administration for Children’s Services (ACS) coordinated investigative efforts with law enforcement upon receipt of the initial report. The criminal case was closed without charges. Due to the family’s religious beliefs, an external autopsy was performed. There were no findings of trauma. The cause and manner of death were listed as undetermined.

The parents were interviewed and reported on the night of the child’s death, the father placed the child on his back to sleep in his crib. He later found the child face-down and unresponsive. The father called emergency services, who responded to the home and transported the child to the hospital where he was pronounced deceased.

ACS conducted home visits and gathered information from collaterals including hospital staff, clergy, and the pediatrician. There were no concerns for the care the parents provided to the children. A blanket was in the child’s crib and was not noted to have been obstructing the child’s airway. The parents were educated on safe sleep recommendations at the time of the child’s birth.

ACS completed Safety Assessments and required reports timely and accurately. The allegations of Inadequate Guardianship and DOA/Fatality were unsubstantiated against the parents. The investigation did not reveal evidence that the actions or inactions of the parents harmed the child. Services including burial assistance and grief counseling were offered to the family. The family did not utilize the burial assistance. The parents were enrolled in bereavement services. The 5-year-old sibling was acting out as a result of the death and was waitlisted for play therapy.

LDSS Response

On 03/02/23, ACS received the fatality report from the SCR. On the same day, a subsequent report was received. Within the first 24 hours of the investigation, ACS contacted the source of the report, notified the medical examiner's office of the death and coordinated investigative efforts with law enforcement. The siblings were assessed to be safe with the parents.

Hospital staff reported the child was well-groomed and appeared to be well cared for. The doctor said the child was not in rigor mortis when the child was brought to the hospital after the father found him face down in his crib. Medical staff provided lifesaving measures to no avail and the child was pronounced deceased.

On 03/03/23, the father was interviewed. He reported checking on the child as it was unusual for the child to sleep for several hours. The father found the child face down and unresponsive. He began CPR and contacted emergency services who responded and transported the child to the hospital.

The mother reported that she was educated on safe sleep recommendations at the time of the child's birth. The parents would place the child on his back, but "tilted". The record did not reflect the reasoning for tilting the child or specifics about the placement. The mother was unsure if the child was swaddled when the father found him unresponsive.

ACS attempted to interview the siblings; however, they did not engage. They were observed to be clean and free from visible marks or bruises.

After completing all casework requirements and offering the family services in response to the death, ACS closed the case.
