This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services has an open case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child's family; any extraordinary or pertinent information concerning the circumstances of the child's death; whether the child or the child's family received assistance, care or services from the social services district prior to the child's death; any action or further investigation undertaken by OCFS or the social services district since the child's death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child's household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child's siblings or other children in the household.**

OCFS' review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS' assessment and the performance of these agencies.

Presenting Information

SM woke up with the SC at approximately 6am on August 28, 2015. SM reports that she then put the SC in the bed with her and they both fell back to sleep. SM awoke around 9:00am and did not see the child. She went looking and asked her father if he had the child, which he did not. SM went back to her room and then saw the SC head wedged in between the bed and wall in an upright position. SC was unresponsive and cold to the touch. SM, screaming, freed the child and carried the child to call 911. The next door neighbor heard the screaming and came over and began CPR. The neighbor is a RN. The ambulance arrived and took SC to the hospital.

Executive Summary

This fatality concerns the death of a male child that occurred on 8/28/15. The medical examiner has indicated that the cause of death was positional asphyxia. The manner of death has been ruled accidental. An SCR report was received on 8/28/15 regarding the death of the SC.

Monroe County Department of Human Services (MCDHS) began a joint investigation on 8/28/15. According to MCDHS the SC woke at approximately 9:00am. The BM removed the SC from his crib and placed him in the bed with her to "snuggle". They both fell back to sleep. The BM woke at approximately 9:00am and the SC was not in the bed with her. BM believed that SC was with the MGF and went to find him. MGF informed her that he did not have the child. BM went back to the bedroom and found the SC wedged between the mattress and the wall. SC was not responsive and cool to the touch. BM removed the SC and called 911. BM was screaming and it was heard by a neighbor. The neighbor, a registered nurse, began CPR. EMT's arrived at 9:14 am and transported the SC to a local hospital. The SC was pronounced deceased at 9:57am.

MCDHS conducted an investigation with LE. MCDHS arrived at the home of the SC at 11:50am. to complete a safety assessment for the surviving sibling in the home. She was deemed safe in the care of her BM and MGF. At the time of the assessment the BM was not at home and the OC was in the care of a neighbor/babysitter. MCDHS did interview the MGF and OC and Babysitter.

MCDHS completed a second interview and assessment on 9/8/16. The home was found neat and clean without hazards. There was plenty of food and again the OC was deemed safe in the care of her BM. BM was offered, accepted and participated in bereavement services. The OC also is receiving services. MCDHS completed collateral contacts with the attending hospital, LE, ME, SC's pediatrician, neighbor and babysitter, MGF, BF's for both children and OC's school. No safety concerns were noted throughout the course of the investigation. The family had no CPS history.

Supervisory reviews were documented throughout the course of the investigation. At the time of this report the fatality case remains open pending determination.

MCDHS is to be commended for their work on this case.

LDSS Response

On 8/28/15 the SCR received a report of a child fatality naming the BM and MGF of Inadequate Guardianship and DOA/Fatality. The SC, a 9 month old male child was pronounced deceased at 9:57am.

The SC woke in his crib and was moved to his BM's bed at approximately 6:00am. They both fell back to sleep. When the BM woke at 9:00am she could not find the SC. She went to her father to see if he had the SC and he did not. She returned to her room to find the SC wedged between her mattresses and the wall. The SC was cool to the touch and unresponsive. LE and ME reported that there were no signs of abuse or maltreatment.

LDSS responded to the home to assess the safety of the surviving sibling. The BM was at the hospital. Following interviews with the OC, MGF and DCP/neighbor, it was determined that the surviving sibling was safe in the care of the neighbor and her MGF. No safety concerns were noted. There was adequate food and heat.

LDSS collaborated with LE, school officials, the ME, hospital, pediatrician and other agencies to ensure the safety and care of the surviving sibling. On 8/28/15 and 9/8/15 safety assessments were completed by MCDHS and OC was deemed safe in the care of her BM. OC continues in counseling. All casework and activities by MCDHS were appropriate and consistent with case circumstances. The case remains undetermined.
