This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services had an open investigation or a CPS monitored services case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

Presenting Information

On 2/1/23, Nassau County Department of Social Services (NCDSS) was notified by the parents, that the subject child died at the hospital. The subject child was hit by a car while riding his bicycle on 1/15/23 and suffered severe trauma. The child was on life-support prior to his death. NCDSS completed a 7065 Agency Reporting Form and notified the Westchester Regional Office on 2/1/23.

Executive Summary

On 2/1/23, NCDSS was notified of the death of the 17-year-old male subject child. At the time of the child’s death, he resided with his mother, father, and 12- and 10-year-old siblings. NCDSS had an open preventive services case at the time of the death to assist the family in addressing the child’s behaviors. The mother, father, and child were actively engaged in therapy with NCDSS and a contracted agency at the time of the fatal incident.

NCDSS learned about the fatal incident after the contracted agency called the mother to schedule their weekly therapy appointment. On 1/15/23, the child was hit by a car while riding his bicycle and suffered severe trauma. The child was transported to the hospital and was placed on life support.

NCDSS spoke with the medical examiner’s office and learned the cause of death was complications of blunt impact of the torso and the manner of death was accident. There was no autopsy performed and medical records from the hospital were used to determine the cause and manner of death. It was unknown if law enforcement investigated the death.

On 2/1/23, NCDSS spoke with the mother and learned the child had passed away the same day. NCDSS spoke to the father on 2/14/23. The father declined a home visit, and the siblings were unable to be assessed following the death. There were no concerns for the siblings throughout the services case. The father was receptive to bereavement counseling and a list of community-based resources were mailed to the father for the family. The father declined to provide NCDSS with any further information regarding the child’s death. A plan amendment FASP was completed regarding the child’s death and the preventive services case was closed on 2/28/23.

LDSS Response

NCDSS was notified of the death of the subject child on 2/1/23. NCDSS was unable to assess the siblings as the father declined a final home visit prior to closing the services case. NCDSS mailed the father community-based resources for bereavement counseling for the family.

NCDSS learned through a review of a law enforcement report on 1/15/23, at about 10:46 AM, the child was riding his bike and was hit by a car. Emergency medical services responded to the scene and transported the child to the hospital. The child had sustained severe trauma and was placed on life-support.

It was learned from the open services case that prior to the fatal incident the mother, father, and child were engaged and participating in counseling services through a contracted agency. The family met weekly, and the child's behaviors improved. There were no concerns documented in the record for the siblings and they did not require services. NCDSS made monthly visits to the home, maintained contact with the contracted agency and the school, and progress notes were entered timely. NCDSS completed the plan amendment and closed the services case on 2/28/23.
