This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services had an open investigation or a CPS monitored services case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

Presenting Information

Oneida County Department of Social Services (OCDSS) received an SCR report on 1/5/2024, which alleged on the same date the mother (SM) brought the 3-month-old child (SC) into bed with her and the father (SF) to sleep. The mother and father awoke at approximately 6:30 AM and found the child unresponsive in bed. The mother and father immediately called 911 and the child was transported to the hospital by ambulance where she was pronounced dead at 7:45 AM. The SCR report alleged the child passed away as a result of the unsafe sleep environment.

Executive Summary

This report concerns the death of a 3-month-old child which occurred while in the care of her mother and father. Within the first 24 hours of the investigation, OCDSS contacted the source of the report, notified the ME and DA's offices of the death, documented a CPS history check, and interviewed hospital staff.

OCDSS interviewed the mother and father in the home with law enforcement. The mother stated she fed the child and placed her in the adult bed to sleep at approximately 3:00 AM, between the father and herself. The mother placed the child on her back with her head on a small baby pillow. The father awoke at approximately 6:30 AM and found the child unresponsive with foam coming from her mouth. The father woke the mother who called 911. The father dressed the child and exited the home, meeting law enforcement and the ambulance outside. The child was transported to the hospital where she was pronounced dead. The parents expressed having no previous knowledge of safe sleep practices. Bereavement services were offered to all family members.

Hospital staff stated the child was free of visible trauma or signs of abuse, though deferred the cause of death to the medical examiner. The medical examiner stated to law enforcement the child must have been in a prone position upon death due to lividity. The final autopsy report was pending at the time this report was written.

The allegations of DOA/Fatality and Inadequate Guardianship against the mother and father regarding the death of the child were pending at the time this report was written. OCDSS noted in the case record they were awaiting the final autopsy results before determining the allegations.

LDSS Response

OCDSS received the SCR report and coordinated their response with LE. LE informed OCDSS the SM placed the SC in the adult bed with herself and the SF at approximately 3:00 AM. The SF awoke at approximately 6:30 AM and found the SC face up, not breathing, and observed foam coming from her mouth. The SF woke the SM who called 911. The SF dressed the SC in a snow suit and left the home, meeting LE and the ambulance outside as they arrived. The SC was transported to the hospital where she was pronounced dead.

OCDSS interviewed the SM in the home with LE. The SM confirmed the narrative of events as reported to OCDSS by LE. The SM added the SC's head was placed on a small baby pillow. The SM and SF stated they had no previous knowledge of safe sleep practices prior to OCDSS reviewing them during the interview. OCDSS interviewed the MGM in the home. The MGM expressed having no previous concerns for the SC in the care of the SM and SF. Information on bereavement services was provided to all family members by OCDSS. It was unknown from the case record if the services were utilized.

OCDSS interviewed LE investigating the death of the SC. LE informed OCDSS the ME stated the SC appeared to have been in a prone position due to lividity. There were no other signs of abuse or trauma present in the SC. LE stated their investigation would remain open pending the autopsy results. Hospital staff were interviewed following the death of the SC. The cause of death was deferred to the ME, though the hospital expressed concerns for the SM's mental health following the death of the SC. No concerns for the care of the SC were identified prior to her death.

The investigation into the death of the SC remained open at the time this report was written. The case record reflected OCDSS was awaiting the final autopsy results prior to making a determination of the allegations of DOA/Fatality and IG against the SM and the SF.
